DIRECTIONS FOR USE + APPLICATION RATE

LIGHT CROP RESIDUE: 1 qt (32 oz) per acre
HEAVY CROP RESIDUE: 1 gal (128 oz) per acre
SOIL CONDITIONER: 2 qt (64 oz) per acre
FOLIAR: 1-4 qt (32-128 oz) per acre
DRY FERTILIZER: 1-2 qt (32-64 oz) per ton
IN-FURROW: 1-2 qt (32-64) per ton

STORAGE AND DISPOSAL

Store in cool, dry place in original container. Keep container tightly closed. Do not reuse empty container. Triple rinse then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
