DIRECTIONS FOR USE + APPLICATION RATE

2 qt (64 oz) per ton of dry phosphorus or potassium fertilizer*

***MicroCoat Ultra** cannot be mixed with urea alone. When adding urea, mix **MicroCoat Ultra** with dry P or K fertilizer, allow time for adequate drying, then blend mix with urea.

STORAGE AND DISPOSAL

Store in a cool, dry place in original container. **DO NOT FREEZE**. Keep container tightly closed. Do not reuse empty container. Triple rinse then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
