DIRECTIONS FOR USE

BROADCAST SOIL TREATMENT: 1-4 qt (32-128 oz or 1-4 L) per acre

NOTE: DO NOT USE AS A FOLIAR SPRAY

STORAGE AND DISPOSAL

Store in a cool, dry place in original container. **DO NOT FREEZE.** Keep container tightly closed. Do not reuse empty container. Triple rinse then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
