APPLICATION RATES

Foliar: Apply 1-2 qt/acre [32-64 oz]

In-Furrow or 2 x 2: Apply 1-4 qt/acre [32-128 oz] with liquid UAN.

Crop Residue: Apply 1-4 qt/acre [32-128 oz] alone or in combination with in-furrow products or liquid starter fertilizers.

STORAGE AND DISPOSAL

Store in a cool, dry place in original container. Avoid freezing. Keep container tightly closed. Do not reuse empty container. Triple rinse then offer container for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
