DIRECTIONS FOR USE + APPLICATION RATE

SEED TREATMENT: 2-6 oz per 100 lbs (or 65-200 mL per 100 Kg) seed

IN-FURROW: 1 qt (32 oz or 1 L) per acre at planting

FOLIAR: 0.5 - 1 qt (16-32 oz or 0.5-1 L) per acre at early vegetative and/or at reproductive stage

STORAGE AND DISPOSAL

Store in a cool, dry place in original container. **DO NOT FREEZE.** Keep container tightly closed. Do not reuse empty container. Triple rinse then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
