## DIRECTIONS FOR USE + APPLICATION RATE

**SEED TREATMENT:** 2-6 oz per 100 lbs (or 65-200 mL per 100 Kg) seed

**IN-FURROW:** 1 qt (32 oz or 1 L) per acre at planting

**FOLIAR:** 0.5 - 1 qt (16-32 oz or 0.5-1 L) per acre at early vegetative and/or at reproductive stage
