CORN

Early Vegetative Stage: 1-2 pt (16-32 oz or 0.5-1 L) per acre

Early Reproductive Stage: 1-4 pt (16-64 oz or 0.5-2 L) per acre

COTTON

4th-5th Node Stage or 1st-2nd Glyphosate Application: 1 pt (16 oz or 0.5 L) per acre

9th Node Stage or After: 1-2 qt (32-64 oz or 1-2 L) per acre

RICE

Flag Leaf: 1-2 qt (32-64 oz or 1-2 L) per acre

SOYBEANS

3rd-4th Trifoliolate: 1 pt (16 oz or 0.5 L) per acre

Early Pod Set: 1-2 qt (32-64 oz or 1-2 L) per acre

WHEAT

Dormancy Break: 1-2 qt (32-64 oz or 1-2 L) per acre

STORAGE AND DISPOSAL

Store in a cool, dry place in original container. DO NOT FREEZE. Keep container tightly closed. Do not reuse empty container. Triple rinse then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
