GENERAL INFORMATION

Prevent NXT is intended to be used as a penetrant to improve phosphorus uptake as supplement to a regulatory fertilizer program and is not intended to provide the nutrients normally required by agricultural crops.

APPLICATION RATES

Liquid Phosphate Fertilizer Use 3 qt (96 oz) per ton
Mix with liquid fertilizer such as starter or side dress liquid blends. It is recommended in combination with pesticides, adjuvants, and other products that a jar test be performed prior to adding **Prevent NXT** to an entire tank mix. Only use in tank mixes containing liquid phosphate fertilizers.

Liquid Manures Use 8 oz per 5000 gal of manure
Apply to slurry pit or through an injection system as material is loaded into the applicator.

STORAGE AND DISPOSAL

Store in a cool, dry place in original container. **DO NOT FREEZE**. Keep container tightly closed. Do not reuse empty container. Triple rinse then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
