GENERAL INFORMATION

Strike NXT is a 4-0-21 fertilizer containing 8% sulfur. It can be applied or mixed with other fertilizers for soil incorporation. **Strike NXT** is formulated to prevent/correct potassium or sulfur deficiencies. **Strike NXT** is a plant supplement and is intended to be used in conjunction with a regular fertilizer program. Utilize a jar test if compatibility is questionable.

DIRECTIONS FOR USE + APPLICATION RATE

FOLIAR: 1-4 qt (32-128 oz) per acre in a minimum of 6 gal of water (or 1-4 L per acre in a minimum of 22 L of water). Do not apply when the crop is excessively stressed or temperature is above 90°F (or 32°C).

SOIL APPLIED: 1-10 gal (128-1,280 oz or 4-40 L) per acre as required by soil analysis.

STORAGE AND DISPOSAL

Store in a cool, dry place in original container. DO NOT FREEZE. Keep container tightly closed. Do not reuse empty container. Triple rinse then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
