Intended for wheat, corn, canola, flax, and alfalfa.

APPLICATION RATE

IN-FURROW: 1-2 qt [32-64 oz or 1-2 L] per acre*

FOLIAR: 1-2 qt [32-64 oz or 1-2 L] per acre*

*This fertilizer should be used on the basis of soil and/or tissue analysis.

STORAGE AND DISPOSAL
