GENERAL INFORMATION

NTensity B combines slow release nitrogen and 0.5% boron to supply safe supplemental foliar nitrogen at critical stages of plant growth. Intended for use as a supplement to a regular fertilizer program.

DIRECTIONS FOR USE + APPLICATION RATE

FOLIAR: Use 1-2 gal (128-256 fl oz) per acre.

Fill spray tank with water prior to adding fertilizer or other products. Repeat applications may be beneficial. Use only as directed to avoid foliar burn. Do not apply when crop is excessively stressed for moisture or during periods of high temperatures. Use of a surfactant may enhance leaf coverage and increase nutrient absorption.

STORAGE AND DISPOSAL

Store in a cool, dry place in original container. DO NOT FREEZE. Keep container tightly closed. Do not reuse empty container. Triple rinse then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
