## GENERAL INFORMATION

**PrimeTime** is an advanced foliar nutritional supplement that provides peanuts, cotton, and soybeans with the nutrients necessary for production in peak growing stages. Always conduct a jar test to confirm compatibility before applying.

## DIRECTIONS FOR USE + APPLICATION RATE

**PEANUTS:** 16 oz with each fungicide application  
**COTTON:** 16 oz with first bloom and 8 oz with each application of growth regulator  
**SOYBEANS:** 32 oz at first post-emergence pass and 32 oz at first bloom with insecticide/fungicide/herbicide application

## STORAGE AND DISPOSAL

Store in cool, dry place in original container. Keep container tightly closed. Do not reuse empty container. Triple rinse then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
